Non-Accredited Course Policy

Reiki Tradition Terms & Conditions

These Terms and Conditions apply to your contract with Reiki Tradition when you enrol onto one of our **Non-Accredited Reiki Courses**. We believe that they are fair and clear. Please read the notes below carefully.

Reiki Tradition is an Accredited Reiki Training Provider

1. It is our policy when you book a course with us to provide you with training towards a Non-Accredited qualification in Reiki.
2. All our Reiki Courses are an Academic Degree in a Reiki Professional Qualification.
3. All our courses meet the syllabus standards of the Qualifications Credit Framework (QCF), the Core Curriculum (CC), National Occupational Standards (NOS) Complementary Health Professionals (CHP) Complementary & Natural Healthcare Council (CNHC) Reiki Council (RC) and the Standards and Code of Conduct as set out by the Federation of Holistic Therapists (FHT).
4. All courses have been Accredited Certified and Verified by the FHT, CHP, CNHC and the RC.
5. All Reiki Tradition Accreditation Certification can be viewed upon request.
6. All Non-Accredited course students will receive a certificate (via Royal Mail) within 28 days of satisfactorily completing the course.

Your Commitment to us:

When you book onto any of our Courses you agree to all our terms and conditions as in the policy set out by us.

7. Attend for the duration of the course.

- a. Reiki 1st Degree two consecutive days, 10.00am until 5.45pm usually 16 hours.
- b. Reiki 2nd Degree two consecutive days, 10.00am until 5.45pm usually 16 hours.
- c. Reiki 3rd Degree four consecutive Monday evenings, 7.00pm until 9.15pm. Then Friday and Saturday evening, Friday 7.00pm until 10.30pm Saturday 7.00pm till 11.30pm. Duration of course usually 17 hours.

8. **Policy for Cancellation/Change to the Enrolled Course**

- Cooling off period of 14 days from time of booking for a full refund.
- No refund will be given for any cancellation/changes after the 14-day cooling off period
- Students can change from a Non-Accredited Qualification to an Accredited Qualification, but the following conditions will apply:
 - (a) The difference in monies to be paid in full
 - (b) Reiki Tradition will supply a new Accredited Case Study Pack
 - (c) Students will comply with the additional training hours in order to meet the Core Curriculum Syllabus Standards
 - (d) Students will complete the required number of Case Studies in order to comply with the Core Curriculum Syllabus Standards
 - (e) Upon completion of the Core Curriculum Syllabus Standards (within a **minimum** period of 9 months) the student will be presented with an Accredited Qualification Diploma Certificate

9. **Cancellation Postponement of Course or Presentation Evening**

In the likely event a course or a presentation evening has to be cancelled/postponed Reiki Tradition School of Reiki will:

- (a) Set a new course or presentation date as soon as convenient from the original date
- (b) Contact all students keeping up to date with all changes
- (c) Liaise with Students asking for students availability to set new date

- (c) Students will not be signed as completed, and students cannot run there own courses without being signed (Completed).
